Option 1) All current officers who were reelected would continue to be paid until their terms end on June 30, 2018 (Hope,Kristy, Jodie, Anne, Jeff, Diane). Don and Stacy would be paid through August 30, 2016. Julie and Phil would start being paid on July 1, 2016 per the Constitution. This option results in the current officers getting two less months over their term (they don't get paid through August, 2018). This option results in Phil and Julie receiving pay for two months (\$1000 total) while Don and Stacy are still receiving their pay. Don and Stacy could also be paid their remaining stipends in June for June, July, and August if we don't want to pay people for the same position at the same time.

Option 2) All current officers (Hope, Kristy, Jodie, Anne, Jeff, Diane, Don, Stacy) are paid their remaining salaries in June for the current year. If their salary is \$3000, they would be paid \$750 for June, July, and August. They aren't receiving any additional funds, but they are being paid early. All elected officers for 16-17 (Hope, Kristy, Jodie, Anne, Jeff, Diane, Phil, Julie) start receiving their stipends on July 1, 2016 for the new year. This option results in payments of \$750 in June for the current officers making \$3000 (Jodie, Stacy, Jeff, Anne, Don, Hope, Kristy) and \$1899.99 for Diane (\$633.33/ month for three months). This option pays all current officers for their remaining months, and starts the new officers on July 1, 2016 per the Constitution. This option results in Jodie, Jeff, Anne, Hope, Kristy, and Diane getting two overlapping months this year. Phil and Julie start getting paid July 1, 2016.
